# 1 INTRODUCTION

This document is to support customers making changes to their XML-PI solution in advance of the new trading relationship between UK and the EU from 2021.

If you need to refer to the full DHL XML-PI toolkit documentation, you can find it here.

# 2 PRODUCT CODE CHANGES

If you're currently only shipping within the EU now is the time to familiarize yourself with customs procedures. If you're currently trading outside the EU, you'll already be familiar with customs requirements. New customs procedures are scheduled to apply when moving goods between the UK and the EU from 2021. The following products will then no longer be able to be used when shipping between the United Kingdom and EU countries.

- DHL Express Worldwide (eu) ECX
- DHL Economy Select (eu) ESU

# 3 CAPABILITY AND QUOTE SERVICE

Included in the request, there is an element in the BkgDetails segment called IsDutiable.

Valid values are:

- N for Non-Dutiable shipments
- Y for Dutiable shipments

#### Example:

### <IsDutiable>N</IsDutiable>

Previously, when requesting capability for shipments between EU countries, N was always used. Moving forward this value will be Y if the contents are dutiable and will incur duty and tax charges. N would still be used if the contents are documents only and will not incur duty and tax charges.

The products returned in the capability response are determined based on this value.



# 4 SHIPMENT VALIDATION REQUEST

#### 4.1 MANDATORY ELEMENTS FOR DUTIABLE SHIPMENTS

# <DutyPaymentType>

The DutyPaymentType element contains the method of duty and tax payment. It is required for non-document/dutiable products.

The valid values are:

S: Shipper

R: Recipient

**T**: Third Party.

# <DutyAccountNumber>

The DutyAccountNumber element contains the account number which is used for duty and tax payment. If this is not provided the **BillingAccountNumber** or **ShipperAccountNumber** values will be used.

#### <Dutiable>

The Dutiable section is necessary for all dutiable/non-document shipments to specify the declared value and tax details for customs clearance and billing purposes.

Example, mandatory highlighted in red:

#### <IsDutiable>

Previously, when creating shipments between EU countries, N was always used. Moving forward this value will be Y if the contents are dutiable and will incur duty and tax charges.

N would still be used if the contents are documents only and will not incur duty and tax charges.

#### 4.2 IMPORTANT ADDITIONAL ELEMENTS

Upcoming EU Regulatory Changes in 2021 will require shippers to provide complete & accurate full line item information (i.e. goods descriptions, HS code & value) and as such it is important to include the **<Commodity>** & **<ExportDeclaration>** elements in any shipment request messages.

# 4.3 USING THE DUTIES & TAXES PAID SERVICE

Where applicable, to ensure that any Duties & Taxes incurred when shipping a declarable product are paid by the shipper, additional information is required in the request message to correctly support DTP shipments.

- <DutyPaymentType> set to 'S'
- <DutyAccountNumber> element included with the relevant account number to be billed
- <TermsOfTrade> set to 'DDP'
- <SpecialServiceType> set to 'DD'



# **5 CUSTOMS DATA & PAPERWORK REQUIREMENTS**

All dutiable shipments must be accompanied by paperwork for Customs. Further information can be found on the DHL website.

DHL's **Paperless Trade (PLT)** service allows you to electronically transmit your commercial invoice data, eliminating the need to create, print and physically attach them to your shipments to many destinations. As well as saving valuable time when preparing shipments, this free service will help save on paper and printing costs, whilst also making a positive contribution to the environment.

Receiving your Commercial invoice data electronically means the customs clearance process can start immediately, giving huge advantages in the quality and lead time performance.

Alternatively, it is also possible to electronically transmit your own Commercial and ProForma Invoice images using the **Paperless Trade (PLT)** service. This method does not require the invoice data to be sent, only the image of your invoice in base64. This option is less efficient and should only be considered if providing invoice data is not possible.

# 5.1 MANAGING CUSTOMS DATA AND DOCUMENTATION IN THE SHIPMENT VALIDATE RESPONSE

#### 5.1.1 REQUEST

The following elements/sections are used to specify the content and type required for the commercial documentation:

- Dutiable
- UseDHLInvoice
- DHLInvoiceLanguageCode
- DHLInvoiceType
- ExportDeclaration

It is important that the ExportLineItem values, totals and units of measure match the values and totals provided in the Dutiable and ShipmentDetails sections.
